IF THAT FIELD IS NOT PLAYABLE, THE FOLLOWING PROCESS WILL BE USED: (1) ANOTHER FIELD IN THE LEAGUE OF THE HIGHER SEEDED TEAM WILL BE CONSIDERED. (2) THE LOWER SEEDED TEAM'S FIELD. ALL FINALS WILL BE PLAYED ON NEUTRAL FIELDS SELECTED FOR LOCATION AND <u>SUITABILITY</u>. ALL GAMES SHOULD START AT 4:00 PM UNLESS MUTUALLY AGREED ON BY BOTH SCHOOLS AND APPROVED BY THE CHAIRPERSON. METHOD OF SEEDING:	
	 Teams will be seeded in the tournament by using the power ranking system described below: Win points—5 points for each win. Schedule points—winning percentage of all opponents on your schedule X5. Bonus points—the winning percentage of the team that your team defeated X12. All schools on your schedule are now included in the calculation including non-PIAA schools. The power ranking is determined by dividing the sum of all the win points, schedule points and bonus points by the number of games played. It is strongly recommended that you play all 20 games. All games should be completed the day prior to the seeding meeting. Coaches of the winning team must report their score to the Score Service 800-756-4570. If you play a non-PIAA school or a non-District One school you must find their win-loss record by noon on May 18 and forward that record to Morgan Funsten (morg2316@yahoo.com)

GAME BALL:

DISTRICT ONE WILL PROVIDE THREE GAME BALLS FOR EACH PLAYOFF GAME. THEY ARE: Dudley (Leather WT 12 Y FP Thunder Heat). THIS IS THE OFFICIAL BALL FOR ALL DISTRICT AND STATE PLAYOFFS. The coefficient of restitution (COR) and compression (375 lbs max-325 lbs +/-50) shall be labeled on all balls. The specifications of color, COR and compression shall be identical for all balls used for the game. The NFHS Authenticating Mark shall be marked on each ball.

ENDING A REGULATION CONTEST: Rule 4.2.2 If a game is ended because of weather conditions, or darkness interferes with the play so that the game is called (ended) by the umpire, it is a regulation game provided:

- a. Five full innings have been played; or if the home team has scored an equal or greater number of runs in four or four and a fraction turns at bat than the visiting team has scored in five turns.
- b. Play has gone beyond five full innings and is called when the teams have no had an equal number turns at bat. The shall be the same as it was at the end of the last completed inning.; unless the homed team in its half of the incomplete inning, in its half of the incomplete inning and scores a run (or runs) which equals or exceeds the opponent's score, in which case, the final score shall be as recorded when the game is called.
- **TIE-BREAKER PROCEDURE**: If the score remains tied upon completion of 9 innings, the player who last completed her turn at bat is placed on second base.
- **SUSPENDED CONTEST:** A PIAA District or Inter-District softball championship contest called (ended) by the umpire before it is a regulation contest, or a regulation contest called for any reason where a winner cannot be determined shall be treated as a suspended contest. The suspended contest must be resumed later that same day or on the next playable day, and it must be continued from the point of suspension with the lineup and batting order of each team exactly the same as the lineup and batting order at the moment of suspension. Players that were not at the suspended game **may** participate in the game when it is continued but are subject to the rules of the game.

WEARING ATTIRE OF COACHES: Rule 3-5-3: Any time a coach is in live-ball area to confer with players or an umpire, or to occupy a coach's box, the coach shall be attired in a school uniform or jersey/coaching shirt with slacks, short or other leg coverings in school colors or colors of khaki, black or gray. Cut off or any type of blue jeans are prohibited. Jackets are no considered part of the coach's attire.

SCOREBOOK:

EACH TEAM MUST KEEP SCORE. HOME TEAM IS RESPONSIBLE FOR SUPPLYING A QUALIFIED SCOREKEEPER AND THE HOME TEAM'S SCOREBOOK WILL BE CONSIDERED THE OFFICIAL GAME BOOK.

SITE MANAGER:

THE ATHLETIC DIRECTORS OF THE SCHOOLS WHERE THE GAMES ARE BEING PLAYED WILL DECIDE IF A GAME CAN BE PLAYED, PROVIDE CROWD CONTROL, CONTACT EACH SCHOOL COMING TO THE SITE WITH APPROPRIATE INFORMATION, DIRECTIONS, ETC. AND HAVE THE FIELD PREPARED. THE ATHLETIC DIRECTOR/SITE MANAGER WILL ALSO CONTACT THE OFFICIALS AND SCHOOLS INVOLVED IF THE GAME IS POSTPONED. THE SITE MANAGER WILL BE REIMBURSED BY DISTRICT ONE.

ATHLETIC TRAINER:

DISTRICT ONE WOULD LIKE TO HAVE AN ATHLETIC TRAINER AT ALL CONTESTS DURING THE PLAYOFFS. IF THE ATHLETIC TRAINER AT THE SITE OF THE CONTEST IS AVAILABLE, DISTRICT I WILL REIMBURSE THIS INDIVIDUAL FOR HIS/HER SERVICES.
