D1 SCORE REPORTING INSTRUCTIONS

- *Phone or Tablet Access* – select your *PHONE* option that “saves” the web page to your ‘HOME SCREEN’ or ‘ADD a *SHORTCUT*’ * *Score Reporting Website* can also be accessed through [PIAAD1 Home Page](#)

1. Click on the **COACH** icon

2. **LOG-IN:**

- USER NAME = Cell Phone # or email address
- PASSWORD = type in your sport (ie: soccer basketball football)

3. **REPORT your GAME SCORE**

- Report scores by 10pm the day of a game
- Home Team to report final score.
 - However either team can report scores. After scores are reported, both coaches will get an email/text message confirming the result
- Coaches must report all scores played v. non-District One Teams

POSTPONEMENTS / CANCELLATIONS

- Report game changes to Tabulator

NON-DISTRICT ONE RECORDS – must be submitted to Tabulator. Coaches are encouraged to email their tabulator non-District One opponent’s records on a weekly basis to ensure accurate Power Rankings.
