## Tournament Manager's Check List

1. Prior to the tournament Seedings will be sent to coaches by D1 Committee, the following will be should be emailed/mailed by manager to the tournament schools.
    - Information concerning places to eat, motels in the area, time to arrive and where to park buses.
    - Only school issued uniforms and attire to be worn by wrestlers, and strongly encourage proper attire for coaches – no jeans or hats allowed.
  2. Rope off wrestling mat area and scorer's tables and have areas assigned for the Press.
  3. Manager may produce a program and money from the sale can be kept by school or club. Brackets can be printed and sold as well. Have an area where updated brackets can be displayed for the spectators to read.
  4. Have an area cleared for presentation of medals and pictures. After the conclusion of the Tournament have all champions gather for a photo and give parents an opportunity to take their own as well.
  5. Miscellaneous
    - Have a Doctor and Trainers available and all sessions, even at weigh-ins.
    - Have ticket takers and sellers in place well before start of session.
    - Have a separate and private room for referees and a coaches' room
    - Provide a warm up area for wrestlers
    - Provide at least three certified digital scales, 4 for regionals.
    - Any wrestler with a skin issue must have a valid note when weigh-ins begin. The Doctor on-site has final say.
    - Consolations are 1-2-2
    - Send results to Chris Lloyd ASAP, Sat. Night.
    - Provide security in Gym and related areas.

## DISTRICT 1 SEEDING PROCEDURE

### Seeding will be done by D1

1. **All wrestlers are to be seeded. The wrestler entered at the seeding meeting is the entry for that weight class. A wrestler cannot change weight classes after being seeded. A forfeit entered at the seeding meeting will remain as a forfeit for that school and weight. Any injured or ill wrestler may be replaced prior to the beginning of weigh-in.**
2. A wrestler moving up two or more weight classes from the weight at which he/she wrestled 50% of his/her matches for tournaments may not be seeded above 4<sup>th</sup> regardless of points.
3. If points are exactly the same, the higher seed will be based on the following criteria:
  - (a) Competition with each other;
  - (b) Returning league, district, regional or state champion in not more than two weight classes above where he wrestled last season;
  - (c) Common opponents;
  - (d) Number of falls, forfeits and defaults;
  - (e) Tech falls;
  - (f) Draw-sticks correctly numbered with available seeds.

Seeding will be determined by a point system. Points will be awarded for:

#### Criterion 1 – Percentage Record for varsity bouts- One point for a win and divide point total by number of bouts

Example 1 15-5 15 divided by 20= 75

Example 2 12-17 12 div. by 29 = 41

**Must have a minimum of 18 bouts to receive full Points... If not, subtract 5 points per match under 18**

Example 3 9-7-- 9 div by 16= 56 then subtract 10= 46 TOTAL

**The minimum number of bouts for the girls post-season will be 12. Subtract 5 points per match under 12.**

#### Criterion 2 - Prestige Points

- Points awarded for highest place earned in last year's post-season tournament.  
**(If wrestler is coming from out of state or private school, his/her information for where he/she placed in his/her post-season tournament must be sent to District 1 Wrestling Chairman to determine his/her prestige points from previous year.**

**For the 2023-24 girls post-season, points will be awarded for placement in the 2023 regional and state tournaments held for girls (even though they were not PIAA events).**

#### Criterion 3 – Caliber of Competition

Points will be awarded for competition against last year's medal winners in PA Regional and States

For the 2023-24 girls post-season, the 2023 regional and state tournaments held for girls will be used (even though they were not PIAA events) to determine caliber of competition.

## 2023-24 Post Season Seeding

All Wrestlers are to be seeded. A wrestler entered at start of seeding is the entry for that weight class and cannot change weight classes after this point. A forfeit entered for seeding will remain a forfeit for that school and weight. Any injured or ill wrestler may be replaced prior to the beginning of weigh-in. If a coach believes an injured or ill wrestler will be available for the post-season he/she should seed that wrestler. **Remember a seeded wrestler cannot change weights after seeding.**

**Criteria #1** – Percentage record of this season’s varsity bouts – won/loss record **District Duals, State Duals and League Tournament matches count for record but not seeding points. For the girls post-season, only bouts from girls-only events will be used.**

Points: 1 point for win

Divide: Points scored by total bouts

Example 1: record 15 wins – 5 losses  $15/20 = 0.75$  or 75pts

Example 2: record 12 wins – 17 losses  $12/29 = 0.41$  or 41pts

**Must have a minimum 18 bouts to get full points...If not, subtract 5 points for each bout under 18.**

**For the girls post-season, the minimum number of bouts is 12. Subtract 5 points for each bout under 12.**

Example 3: record 10 wins – 4 losses  $10/14 = 71 - 20 = 51$

**Note: Always round out to two decimal points**

**Criteria #2** – Prestige points (awards bonus points for wrestler’s previous year) **A wrestler who transfers into PIAA D1 for this season and was a place winner last season in another state or National Preps, will be given Regional criteria points. District points will be awarded for State Prep placers. For the 2023-24 girls post-season, the 2023 girls regional and state tournaments will be used (even though they were not PIAA events).**

**Substitute Wrestler:**

When a wrestler is removed from the tournament and is a:

- A. Seeded wrestler, each wrestler seed below him/her moves up one place.
- B. (Boys AAA ONLY) All Substitutes for AAA Regionals from AAA Districts will be determined by:
  - (1) The 5<sup>th</sup> place finisher will be selected first.
  - (2) The 6<sup>th</sup> place finisher will be selected second.
  - (3) The wrestler with the most seeding points coming into the district tournament is next.

Substitute wrestler may enter tournament due to illness/injury prior to seeding or prior to start of tournament up until weigh-ins

## Wrestler Receiving Exceptional Seeding Approval

**All coaches who believe they have a wrestler who may be eligible for exceptional seeding MUST contact their League Rep, Steering Committee Chairman Dennis Kellon and Chris Lloyd prior to sending line-up for seeding purpose.**

**Notes: Need criteria for seeding outstanding wrestler who missed season/seeding points** (either previous or during season due to absence from the sport or injury/illness) Also no penalty for minus points missing match minimum.

Any returning Regional medalist or greater from any previous season who wrestles in less than 12 matches (not including district/state duals) in the 2023-24 season can petition the District One Steering Committee to seed that wrestler by "human judgement" instead of solely based on points. The points will be calculated for that wrestler, but the steering committee (or sub-committee appointed by the chairman) has the right to move that wrestler to what they feel is an accurate place in the bracket.

Girls who compete on a boys team for the regular season will be seeded based on multiple factors by a sub-committee, since they will have no record against girls.

Coaches entering a female wrestler from a boys team into the girls post-season must notify the Dennis Kellon and Mike Leister by 6 PM on Friday, February 9th which girls (and their weights) will be competing in the girls post-season.

*\*D1 Wrestling Chairman and/or designated committee will make exceptions and ultimate decisions as needed.*

A spreadsheet will be provided to all Coaches and Tournament Directors with all District One Wrestlers post-season points. The spreadsheet will be provided by Mike Leister. If you have concerns you may contact Chris Lloyd or Glenn Kaiser if corrections need to be made. These points will include the total points for each wrestler entered into District Tournaments for the post-season individual PIAA Championships. All entries for the boys will be due by 6:00 pm on the Wednesday prior to the District Tournaments.

Any issues with results or points calculations need to be brought up ASAP so they can be addressed prior to the seeding deadline.

Another link will be sent to coaches closer to the lineup submission deadline to submit their post-season lineup.

# Seeding Process for South East AAA Regional

## What is changing?

All 16 wrestlers in each weight class of the South East AAA Regional tournament will be seeded based on a combination of how they placed in the qualifying tournament and a seeding points calculation.

Currently only the champions of the 4 qualifying tournaments are truly seeded, while all other qualifiers are placed into the bracket based on their placement in the qualifying tournaments.

## Purpose of the Changes

The goal of the seeding changes is to seed all wrestlers in the tournament more accurately than the current system. The intent is to not only get the best 5 AAA wrestlers per weight to represent District 1 at the PIAA State Championships, but also to get them in the best order of finish as well.

This new procedure accounts for the qualifying tournaments not being balanced, since they were created purely by geography.

## Main Seeding Changes

The new seeding will comprise of 2 main components:

1. Placement in the qualifying tournament the week prior to the Regional
2. Seeding points calculation

## *Adjusted Seeding Points Calculation*

The points calculation that has been used for several seasons in District 1 will be used, with a minor adjustment. After the qualifying tournament, each wrestler will receive additional points for their placement in the qualifying tournament as well as for the caliber of competition they had in the qualifying tournament. The same criteria as the regular season formula will be used to determine those additional points.

The seeding formula used prior to the start of the post-season can be found here:

For example, Wrestler A has 125 points prior to the start of the post-season. Winning his qualifying tournament earns him an additional 25 points. During the qualifying tournament, he also beat a returning regional champ (which earns 30 more points) and lost to a returning state 5<sup>th</sup> placer (which earns 4 more points). Wrestler A's seeding points for the regional tournament will be 184.

The steering committee can make adjustments in seeding points for “outstanding wrestlers” who missed parts of the season due to injury. The language for that eligibility is in the link above, but it may have to be altered slightly to account for this new regional seeding.

## *Key Notes*

With these changes, there are a few items that should be noted.

- Wrestlers cannot be seeded above anyone who placed higher than them in their qualifying tournament.
  - First round matchups could feature wrestlers from the same qualifying tournament.
-

- One qualifying tournament could have the top 4 seeds (or the bottom 4 seeds) in a weight class.
- Qualifying tournament champions could be seeded anywhere from #1 to #13.

Seeding all 16 wrestlers per weight class strictly via seeding points is not recommended as that takes away the importance of the qualifying tournament placement (ie: wrestlers could forfeit after advancing to the finals).

## New Regional Seeding Procedure

All 16 wrestlers per weight class who qualify for the South East AAA Regional will be seeded. Should a wrestler withdraw from the regional for any reason, the entire bracket would be reseeded with the replacement.

### Order for Wrestlers to Get Seeded

Wrestlers will be sorted by their placement in the qualifying tournament (higher place to lower place) and then by their seeding points (highest to lowest). This order will be used to determine when a wrestler is seeded.

### Seeding Criteria

When seeding each wrestler, there are 2 main criteria used. Each wrestler will be seeded:

1. AFTER the wrestler who placed just above him in their qualifying tournament
2. BEFORE the highest seeded wrestler below the previous placer with fewer points than the wrestler being seeded

### Detailed Example of New Seeding through 8 Wrestlers
