

REGIONAL TOURNAMENT

Procedure for Class AAA Regional Tournaments

The Regional Wrestling Tournament is State Sponsored and will be conducted according to the procedures set forth by the District 1 Steering Committee and the Pennsylvania Interscholastic Athletic Association.

- 1 Weigh-In: Friday: 4:30PM (scales will be opened for unofficial weight checks from 4:4-4:29 PM)
Saturday: 8:30AM (scales will be opened for unofficial weight checks from 8:00-8:29)
 - The Head Official will be assigned to do the official skin check at the weigh-ins. **Any wrestler with a skin issue must have a valid note at beginning of weigh-in. Final say is the Doctor hired on site.**
- 2 First Sessions: Pig tails and Quarters
 - Wrestling begins on Friday at 5:30 PM on a minimum of 5 mats.

Second Session: Sat. 9:30 AM First round Wrestle backs to be followed by Semi's

 - **Semi's use 2 mats and 2 for wrestle backs**
 - Semi-Final round will be wrestled on the first available mat. Round of consolations will also be wrestled at this time.
 - A fifteen-minute break after this round and then wrestle backs on three mats.
- 3 Third Session: (Consolation and Finals)
 - **Championship and Consolation Finals and 5th/6th wrestling is to begin at 6:00 p.m. by weight class. Finals on Center mat. The Hall of Fame Induction Ceremonies is to begin at 5:30 p.m. followed by the AAA Coach of the Year presentations and then the Parade of Champions at 5:45 PM.**
 - Circumstances may require a change from alternating mats. The Tournament Manager, Steering Committee Representative and Head Referee will make the decision.
- 4 Officials: 10 officials will be used for the tournament with one Head official. Mat Judges are to be used for all matches
- 5 Officials' Duties: Will be specified by the head referee.
- 6 Timers and Scorers
 - First Session: 5 mats - one timer & one scorer on each mat.
 - Second Session: 4 mats for 4 rounds - one timer & one scorer on each mat.
 - Timers must remember that consolation bouts are 1-2-2 minutes in length.
 - Third Session: Championship and Consolation Finals. 3 mats - one timer & one scorer on each mat.
 - Experienced and Responsible adults should be considered for this job.
- 7 Ticket Sellers / Ticket Takers:
 - **Please try to keep the number of workers to a minimum.**
- 8 Announcer - Clerk:
- 9 Matchmaker / Computer/ Charts/ Scoring:
- 10 Tournament Manager and Assistant:
- 11 Steering Committee Tournament Supervisor: D1 Chairman
 - **The supervisor must also meet with the tournament director prior to the tournament to discuss fees and the emergency response plan for the school**
 - **The host school will provide a minimum of two certified scales for all weigh-ins; DIGITAL SCALES ARE REQUIRED**
- 12 A Physician should be in attendance at all sessions. Be certain to provide at least a trainer and have available emergency ambulance service for all sessions where a doctor is not available. The Athletic Trainer appropriated by the host school is the only one permitted in and on the mat area. Individual school trainers may work with their athletes out of the mat area only.
- 13 A Photographer for \$50.00 (1 session)
- 14 Weigh master assigned by District 1 Supervisor.
- 15 District 1 Supervisor will assign evaluator of Officials to be determined by the State.

- 16 Police: Will be paid according to department policy. Tournament supervisor must approve the fees.
- 17 Refreshments: Must not exceed \$175.00. Receipts must be included in financial report.
- 18 Consolations:
- All contestants who lose in the quarterfinals Friday night will wrestle again Saturday morning at approximately 10 AM.
- 19 Miscellaneous and / or additional fees will require the approval of the District 1 Exec. Secretary.

Sample of the Bracket Format: (See addendum)

23 Complimentary Tickets:

- State comps to be given to those schools that advance a wrestler to the State Finals.

24 Passes:

- The following passes will be honored for all sessions:
 - District One Complimentary Passes
 - Wrestling Steering Committee Passes
 - Working Press Passes
 - College Recruiters & Wrestling Coaches with Credentials
 - **League Passes Will Not Be Honored**

26. **Seeding for Regionals Class AAA**

- A. The District 1 West will advance 4 wrestlers into the SE Regional Tournament.
- B. The District 1 Central will advance 5 wrestlers into the SE Regional Tournament
- C. The District 1 East will advance 4 wrestlers to the SE Regional Tournament
- D. Only the first place finishers of each district tournament will be seeded. All other wrestlers will be placed accordingly as per the addendum for the SE Regional Brackets. See at end of Chapter.
- E. Seeding will be based on the current point system.
- F. See bracket in the back of manual

27. District One Team Champion:

- A running team score should be kept at the head table.

28. Awards:

- The State provides medals for the top four place winners.
- The District Team Champion will be recognized.

29. State Tournament:

- a. The Top Five place winners will advance to the state finals.
- b. Information concerning the state tournament must be picked up at the head table during and after the finals.

30. Payment of workers:

- a. As Per instructions at the Tournament Managers Meeting.

31. Picture for the State Program:

- a. A picture of all the regional champions must be taken after the finals Saturday night. The picture must be e-mailed to hugginsprinting@aol.com, Dr. Robert Lombardi and Mark Byers **immediately** after the finals. Send to all three e-mail addresses.
- b. The first five place winners' names, weights, and records must be faxed to the PIAA office immediately after the tournament.
- c. The championship picture should include the names from the bottom left to right and then the top left to right.

32. Broadcasting of Tournament:

- a. Educational Channels or school based radio / television broadcast - No Fee.
- b. Commercial Radio - \$125.00 per tournament, \$75.00 per session.
- c. Commercial Network or Cable Television - \$200.00 / Entire Tournament or \$100.00 per session.
- d. Broadcasting and Television fees for each tournament. Refer to Mr. Rod Stone, Executive Secretary District 1 PIAA, (610) 519-9525.

REGIONAL TOURNAMENT MANAGER'S CHECKLIST - AAA

PHYSICAL SET-UP OF GYMNASIUMS

- _____ 1. 4/5 mats of equal size each having a visible standing floor clock or standard wall clock.
- _____ 2. Place a "T" in front of the chairs on the mat where the coaches are to sit for the wrestler on the top of the bracket.
- _____ 3. 2 sets of red and green anklets available at each scorer's table. One should be kept as a spare in case of breakage or if one is lost.
- _____ 4. Some sort of visible scoring cards or overhead projector, etc. for coaches and spectators to see.
- _____ 5. Different sound mechanisms should be used to end the bouts on each mat. The sounds should be different as possible so that the wrestlers and the officials do not become confused with signals from another mat.
- _____ 6. There should be a person assigned to each scoring table for injury timeouts.
- _____ 7. P.I.A.A. score sheets should be provided for the official scorer.
- _____ 8. Wall charts should be placed on a wall inside the gymnasium or in the foyer for all spectators to see. These wall charts are usually given to the individual champions at the end of the tournament.
- _____ 9. It will be necessary to have two runners for each mat to carry score sheets to and from the head table.
- _____ 10. The area where the timers, scorers, and announcer are situated should be roped off so spectators cannot walk in front of them. Wrestlers and coaches are not permitted on open mat during competition.
- _____ 11. Team scoring charts should be in full view and kept up to date after each round.
- _____ 12. All coaches / teams are responsible for the care and cleanliness of the host school's gym and locker room areas. Inspect all areas used by teams, coaches and officials prior to leaving the premises on Saturday night.
- _____ 13. **A floor clock or wall clock is mandatory for each mat in use. This was made mandatory by the district steering committee starting with the 2007 Regional tournament.**

PAPERWORK

- A. Record sheets for all champions to be handed to the steering committee member for seeding purposes in the next tournament.

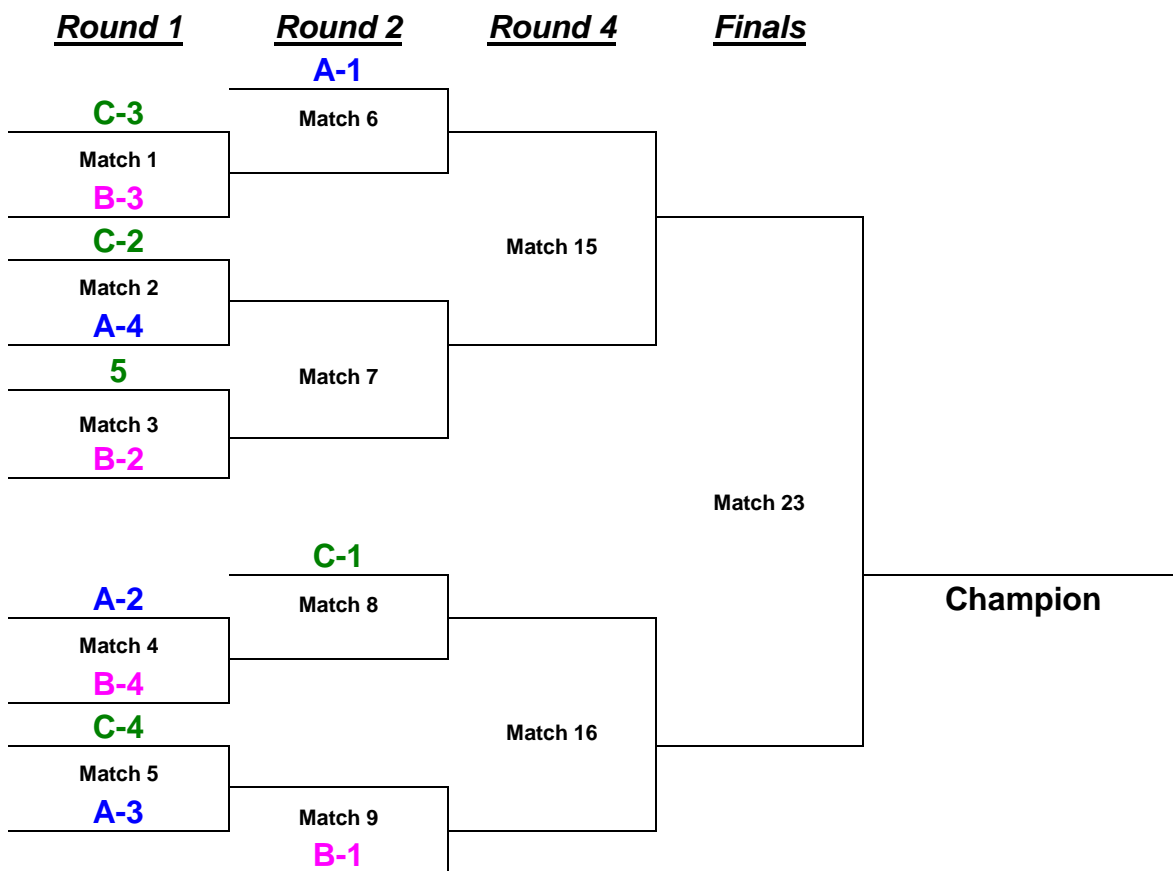
MISCELLANEOUS

- _____ 1. Have a doctor, trainer or emergency ambulance service at all sessions.
- _____ 2. Police where needed.
- _____ 3. Weigh-in room with three certified scales - **DIGITAL SCALES ARE REQUIRED**
- _____ 4. First aid room or area.
- _____ 5. A warm-up area or room for wrestlers.
- _____ 6. Ticket takers and sellers should be in place well in advance of the scheduled starting times.
- _____ 7. Notify restaurants of the tournament so they can have extra help on hand to expedite serving and cooking for wrestlers and coaches.

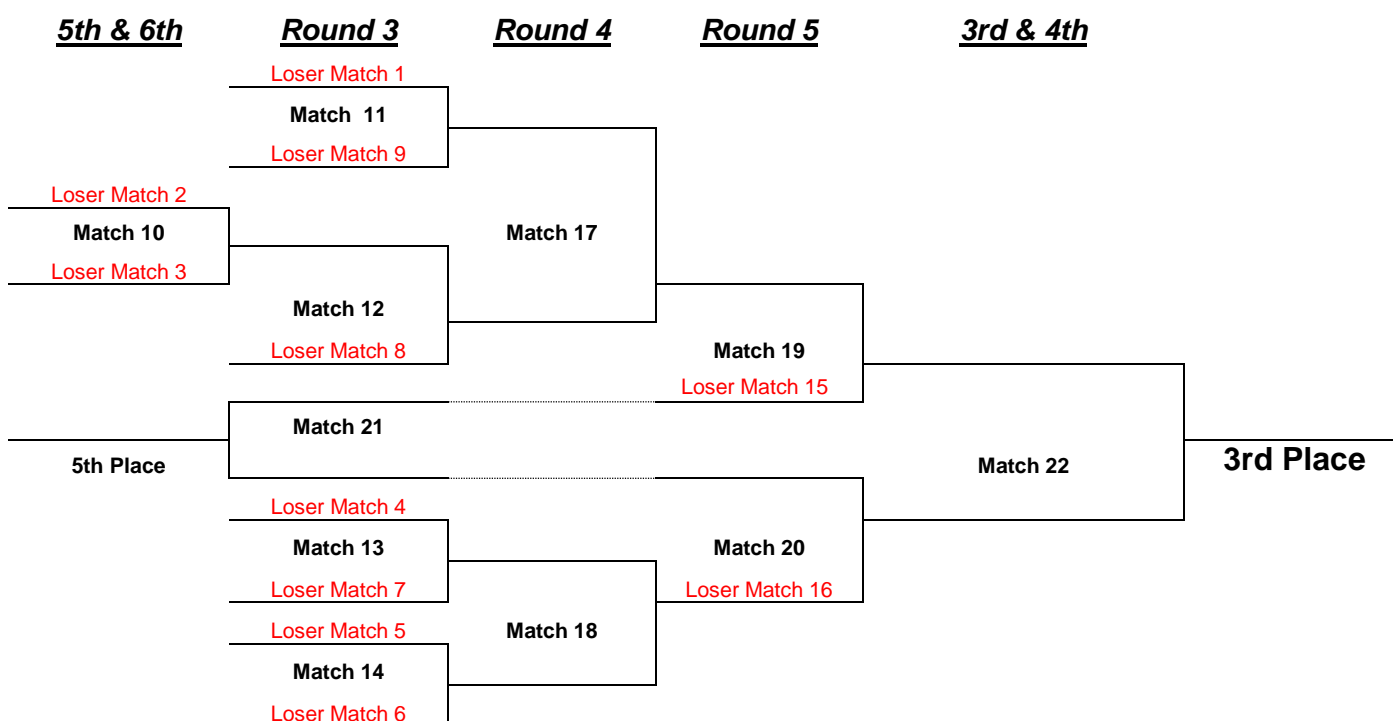
- _____ 8. Notify local news media of all starting times, prices, etc.
- _____ 9. A facility, separate from the wrestlers, for officials.
- _____ 10. Coaches' room with coffee and refreshments.
- _____ 11. Have a means of presenting individual trophies and the outstanding wrestler award.
- _____ 12. Picture taken of all champions together.
- _____ 13. Tournament Program - The tournament director is responsible for preparing and distributing / selling a tournament program to spectators. The following information should be included in programs for all District 1 Tournaments:
- List of participating teams.
 - Map of surrounding area including restaurants, fast food places and lodging.
 - List of all post season tournaments (Dates & Sites) involving District 1 Teams.
 - List of Tournament Personnel (i.e. District 1 PIAA, Tournament Supervisor, Director).
 - Statement concerning crowd control (i.e., abusive fans, videotaping, etc.)
 - Charts for team score.
 - Criteria for team scoring.
 - Time table for events for that tournament.
 - Brackets (include school, grade and record). Give district placing for regional bracket. **CHECK ALL NAMES FOR CORRECT SPELLING.**
 - Previous year's place winners, team scores, and finals results.
 - List names / chapters of all PIAA Tournament Officials.
 - > **Ad for Ken Shield product should be in Programs. See attachment**
- Tournament programs may be done in concert with your local booster club, varsity club, or any other school support group designated and approved by the tournament director. The sponsoring group may keep the proceeds from these sales if tournament funds have not been used to pay for the cost of printing.
- _____ 14. Post brackets for State Championship (SE AAA). Reproduce copies for all coaches with qualifiers.
- _____ 15. Sale of Regional Tournament Mementos (T-shirts, hats, etc.) should be conducted by wrestling booster club or other school support organization.
- _____ 16. Announce, prior to each session, that tournament officials have the right to remove abusive fans from the tournament premises.
- _____ 17. Copies of all bout sheets must be available to all coaches at the conclusion of the final bout of competition.
- _____ 18. E-mail and Fax capabilities need to be available.
- _____ 19. **A photo copier must be made available to the head table.**

CRITERIA FOR DETERMINING TEAM CHAMPION OF EACH TOURNAMENT

Section 2: **Team Scoring** (pages 44-48 in NF High School Wrestling Rules Book)

Art. 2: **In Tournaments**, individual placement points shall be awarded as soon as earned. Placement points already earned will be deducted in case of forfeit (other than injury) or disqualification from the tournament.

Points for team scoring will be awarded as follows:

- a. **Two (2) team advancement points** shall be scored for each match won in the championship bracket, except for the final first place match. If a wrestler receives a bye in the first round, he shall be awarded 2 advancement points for that round if he wins his next match. No points are awarded for the bye if the wrestler loses his next match;
- b. **One (1) team advancement point** will be scored for each match won in the consolation elimination, except for the final third and fifth place matches. A wrestler who has a bye in the consolation round shall receive one advancement point, provided he wins his next round match;
- c. **Two (2) additional points** shall be scored for each match won by default, disqualification, fall, or forfeit throughout the tournament.
- d. **1 1/2 additional points** will be scored for each match won by a technical fall.
- e. **One (1) additional point** shall be awarded for each match won by a major decision.
- f. **In tournament scoring four (4) places**, the winner of each championship semi-final shall be awarded ten (10) place points and the winner of each championship final shall be awarded four (4) additional place points. The winner of each consolation semi-final shall receive four (4) place points and the winner of third place shall receive three (3) additional place points.
- g. **In tournaments scoring six (6) places**, the winner of each championship quarterfinal shall be awarded three (3) place points. The winner of each championship semi-final shall be awarded nine (9) additional place points and the winner of each championship final shall be awarded four (4) additional place points. The winner of the quarterfinal consolation match shall receive three (3) place points. The winner of the consolation semifinals shall receive four (4) additional place points. The winner of third place and the winner of fifth place shall receive two (2) additional place points.
