- Wrestling Postseason begins this week.
 - Team Dual Championships at Upper Dublin HS – 1/31
 - District and Regional Tournament information is posted on the District One website.
- Swimming / Diving - information is posted on the District One website. Coaches will receive information for seed meetings and to verify qualifying times.
- Reminder to member schools that postseason waiver requests must be received 30 days prior to the first the start of the sport postseason. PIAA appeals must be requested 15 days prior to the postseason.
- The annual spring PIAA / District One meeting for principals and athletic trainers will be held on April 8th in zoom beginning at 9:00 AM.
- The PIAA Flag Football Steering Committee Meeting was held today 01/21/2026. Minutes from the state meeting will be sent out to all member schools. There are still some concerns in reference to the newly adopted NHFS Rule books.

New Business

- Upon motion by Ron Reidinger/Steve Brandt, the committee approved the process for recommending and assigning officials for District One and PIAA and championships. The motion ensures that District One assigns officials with no discrimination and all have equal opportunity to apply for a position as an official in the playoffs. **Unanimous (20 Votes).**
- Rod Stone presented a first draft recommendation by the Girls Wrestling Steering Committee for Post-Season 2026-2027. Conversations will continue with schools districts to determine the number of girls coaches, wrestlers, and the number of full girls rosters.

PIAA BOD Report

- The PIAA BOD approved the elimination of overtime in regular season soccer contests
- The PIAA BOD approved “Coaching on the Fly” in the sport of Tennis. More details and specifics will be provided. Approved beginning of Fall 2026.
- PIAA issues a press release for the approved Fall Championship sites for Fall 2026-2030.

Old Business

- Foreign Exchange / International Student eligibility.
 - Seth Frankenfield spoke to the committee in reference to Foreign exchange and international student eligibility. Currently foreign exchange and international students are only permitted one year of athletic eligibility. Mr. Frankenfield made a motion to the District One Committee to consider asking the PIAA BOD to review Article VII and increase the athletic eligibility for foreign exchange and international students from 1 year to multiple years of participation. Upon motion by Frankenfield / Wallace the committee denied the request to take this request to the PIAA BOD. **Votes Yes-10 No -10**

Officials Report – Ron Reidinger & Maureen Gregory

- Ron Reidinger presented that the PIAA officials’ committee voted to approve adopting the officials’ Flag-Football uniform to be the same model as Tackle Football. Upon motion by Ron Reidinger/RJ Bretz the committee has requested PIAA District One leadership request to the PIAA Board of Directors that the Lacrosse officials’ uniforms be considered. **Unanimous (20 Votes)**
