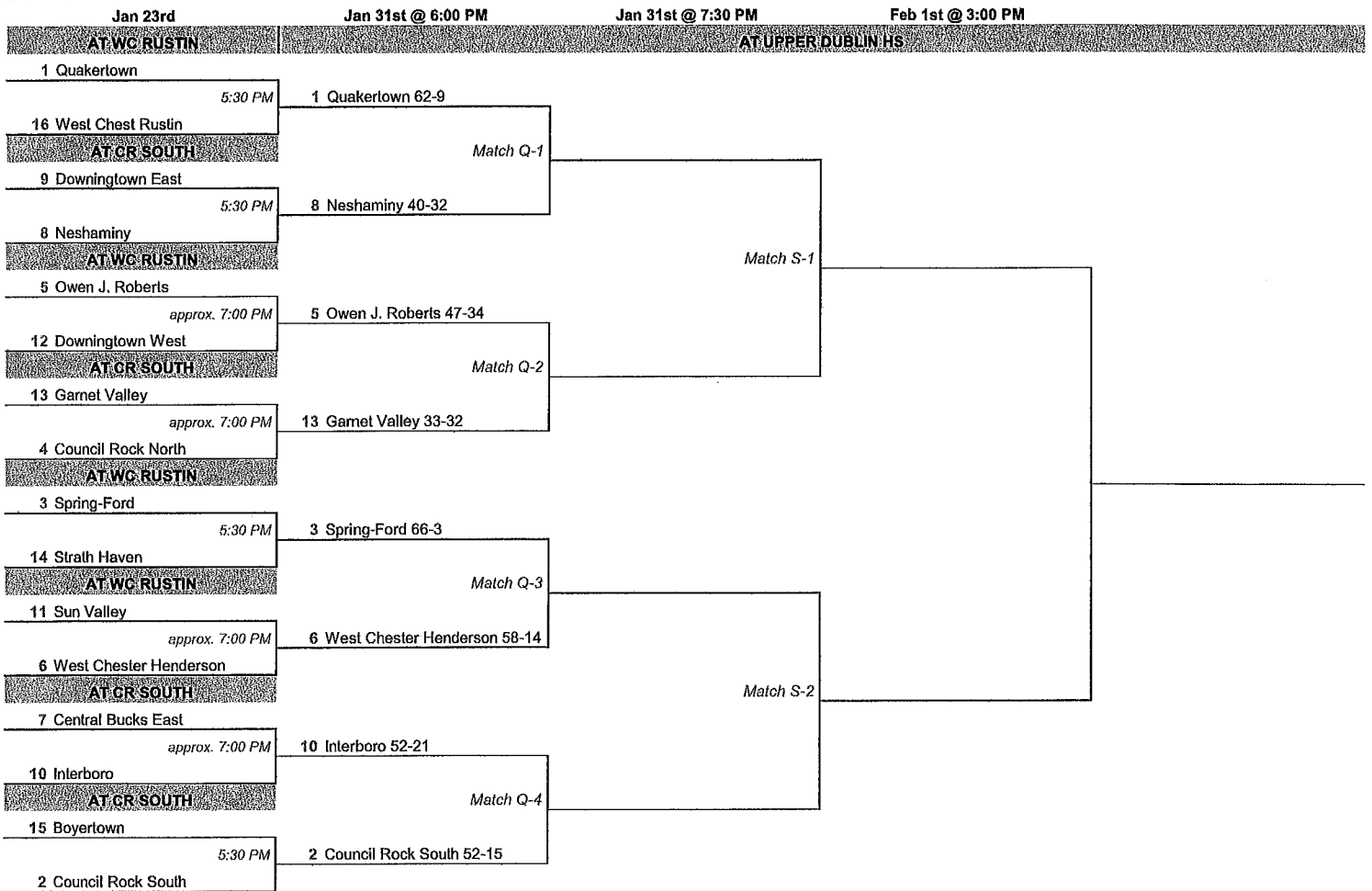

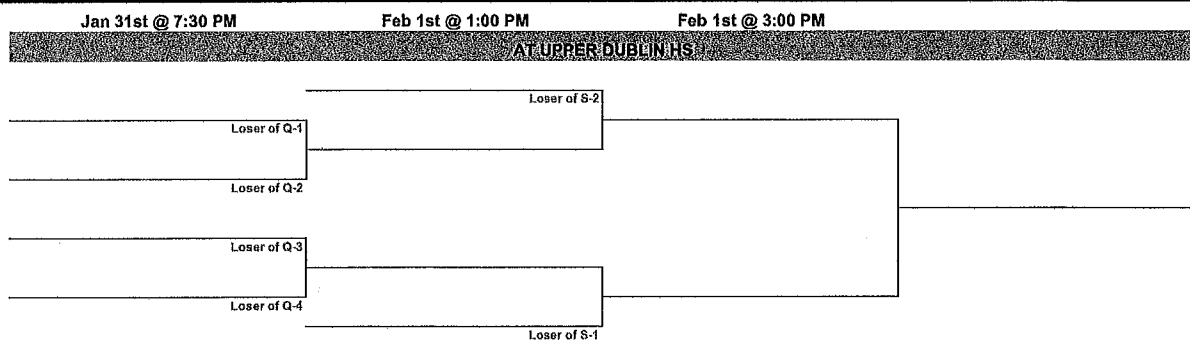

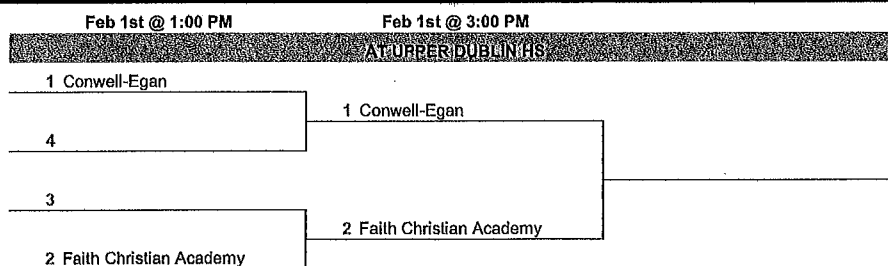
Class AAA Championship Bracket

GENERAL INFORMATION:

2019-2020 PIAA TEAM WRESTLING CHAMPIONSHIPS

PURPOSE OF HANDBOOK

The purpose of this handbook is to develop the format for and to inform the PRINCIPAL, ATHLETIC DIRECTOR, AND HEAD WRESTLING COACH of each member school concerning the 2019-2020 PIAA Team Wrestling Championships, which are scheduled on a preliminary round regional basis for Monday, February 3, 2020. First round matches are scheduled for Thursday, February 6, 2020. First round consolation, quarterfinal, second round consolation and semi-final round matches are scheduled for Friday, February 7, 2020. Third round consolation, fourth round consolation, consolation final, and championship (final) matches are scheduled for Saturday, February 8, 2020, all at the GIANT Center, Hershey, PA.

The 2019-2020 PIAA Team Wrestling Championships shall be conducted pursuant to all applicable By-Laws, Policies and Procedures, and Rules and Regulations of PIAA. It is important that the Principal, Athletic Director, and head wrestling Coach of all Teams that will participate in the 2019-2020 PIAA Team Wrestling Championships and all persons who will have responsibilities involving these activities be fully informed of the policies and procedures described herein. It is also necessary that everyone associated with these championships comply with all policies and procedures without exception.

CONDITIONS OF ENTRY INTO PIAA CHAMPIONSHIPS

PIAA member schools are not required to enter PIAA championship events. Entry and participation in the 2019-2020 PIAA Team Wrestling Championships are voluntary. Entry into the 2019-2020 PIAA Team Wrestling Championships signifies that the member school accepts the fact that the Executive Director, or the Executive Director's designee, reserves the right to make changes in the date of Contests, location of Contests, management, operation, and schedule of the 2019-2020 PIAA Team Wrestling Championships if, in the judgment of the Executive Director, or the Executive Director's designee, it becomes necessary to do so.

ENTRY POLICIES AND PROCEDURES

A representative of each school that qualifies a Team for the 2019-2020 PIAA Team Wrestling Championships must complete the electronic Team Information Form found on the PIAA Web site at www.piaa.org ([sports-wrestling](http://www.piaa.org)) and forward a PIAA Certificate of Eligibility and an appropriate Team picture as follows:

1. Submit the electronic Team Information Form at www.piaa.org ([sports-wrestling](http://www.piaa.org)) and **forward** a Team picture with a resolution of 266 dpi, or greater, in either Bitmap or JPEG format, to mbyers@piaa.org.
2. If electronically forwarding an appropriate Team picture is not possible, then courier or USPS Express Mail the Team picture to the PIAA Office.

PLEASE DO NOT FAX TEAM PICTURES. THE DEADLINE FOR SUBMITTING THE ELECTRONIC TEAM INFORMATION FORM AND FORWARDING AN APPROPRIATE TEAM PICTURE IS 12:00 P.M., MONDAY, FEBRUARY 3, 2020. NO EXCEPTIONS.

In addition to the directions listed above, each school will be provided from their PIAA District Team Wrestling Championships Tournament Director with administrative forms necessary for their participation in first round through championship (final) round competition at the GIANT Center. Included in the packet will be directions for accessing the facility, administrative preferred parking and complimentary admission instructions, and contact information to be supplied by competing school's administration. The forms may also be accessed on the Team Wrestling page of the PIAA Web site at www.piaa.org ([sports-wrestling](http://www.piaa.org)).

Finally, it is imperative that each PIAA District Team Wrestling Championships Tournament Director CALL Mark E. Byers, Chief Operating Officer at (717) 805-5464 and provide the names AND the overall won-loss records of the schools that have qualified for the 2019-2020 PIAA Team Wrestling Championships. This must be done IMMEDIATELY following the conclusion of the District Team Wrestling Championships.

PRELIMINARY ROUND CONTESTS, FORMAT, AND HOME TEAMS

Schools that qualify for the preliminary round will be notified concerning their opponent, home/away Team, location of Contest, date of Contest, starting time of Contest, and name and telephone number of the PIAA-Appointed Contest Manager **BY THEIR PIAA DISTRICT TEAM WRESTLING CHAMPIONSHIPS TOURNAMENT DIRECTOR.**

Principals or Athletic Directors of competing schools, upon notification of relevant information from their PIAA District Team Wrestling Championships Tournament Director, should **IMMEDIATELY** contact the PIAA-Appointed Contest Manager of their respective Contest and (1) confirm the opponent, home/away Teams, location of Contest, date and starting time of Contest; (2) arrange for a locker room, if needed; (3) obtain directions to the Contest site; (4) state the departure time of the Team and the approximate time of arrival at the Contest site; (5) state the anticipated number of spectators from the school and community that will attend the Contest; and (6) state a telephone number at which the Principal or the Athletic Director will be available, up to the announced departure time of the Team.

HOME TEAM, BENCHES, AND BENCH DECORUM

The Teams listed at the top of the brackets (enclosed) shall be the HOME Team for all preliminary round matches.

For all first round through championship (final) matches, which are scheduled to be held at the GIANT Center, Hershey, PA, a coin flip will occur at the match site in the presence of the Coaches/captains of both Teams. The Team listed at the BOTTOM of the bracket (pairing) will call the coin flip.

DESIGNATION OF PRELIMINARY ROUND LOCKER ROOM FACILITIES, BENCH, AND HOME/VISITORS SEATING

The PIAA-Appointed Contest Manager shall designate the preliminary round location of each Team's locker room facilities, Team bench, and home/visitors seating.

Contestants are requested to bring their own locks for use in the designated locker rooms. It is recommended that all articles of value such as money, rings, watches, etc. are not left in the locker room at any time, but are collected by and remain in the possession of a responsible adult designated by each participating school. PIAA and/or the host facility are not responsible for any lost or stolen articles.

STARTING TIME

The preferred starting time for all single and concurrent evening preliminary round Contests is 7:00 p.m.

The preferred starting times for all double-header evening preliminary round Contests are 6:00 p.m. and 7:30 p.m.

INCLEMENT WEATHER/POSTPONEMENTS

Teams must be prepared to participate in the event of inclement weather. If at all possible, Inter-District Championship Contests will be wrestled as scheduled. It shall be the decision of the PIAA-Appointed Contest Manager as to whether a Contest should be postponed because of inclement weather and/or hazardous travel conditions. Postponed Contests must be played later in the day or on the next playable day, at the original Contest site, and at the original starting time, if possible.

POLICY RELATING TO INCLEMENT WEATHER DURING DISTRICT AND/OR INTER-DISTRICT CHAMPIONSHIP TOURNAMENTS

The decision whether to postpone a Contest during a PIAA District and/or Inter-District Championship Tournament, prior to the start of such Contest, is the responsibility of the PIAA District-Appointed Contest Manager, in consultation with the PIAA District Tournament Director, or the PIAA-Appointed Contest Manager, in consultation with the PIAA Tournament Director, within their respective jurisdictions. Once a Contest begins, said decision is the responsibility of the Contest Official(s).

NOTE: Consolation Round matches shall consist of three periods. The first period will be one minute in length, and the second and third periods will be two minutes in length.

PIAA Team Wrestling Championships Tournament personnel will conduct all weigh-ins adjacent to the Green Room in the GIANT Center and PIAA Team Wrestling Championships Tournament physicians and certified athletic trainers will conduct a skin condition check at each weigh-in. There shall be a one-pound allowance granted each day over the weight limit of the previous day up to a maximum of two pounds.

All wrestlers must weigh-in each day (the wrestler intends to participate) of the multiple day event and may weigh in at any weight class their Minimum Wrestling Weight (MWW) determined by the Optimal Performance Calculator (OPC) makes them eligible. This includes weighing in at either a lower or higher weight class than presented on a previous day of the event. EACH WEIGH-IN MUST BE RECORDED IN TRACKWRESTLING.

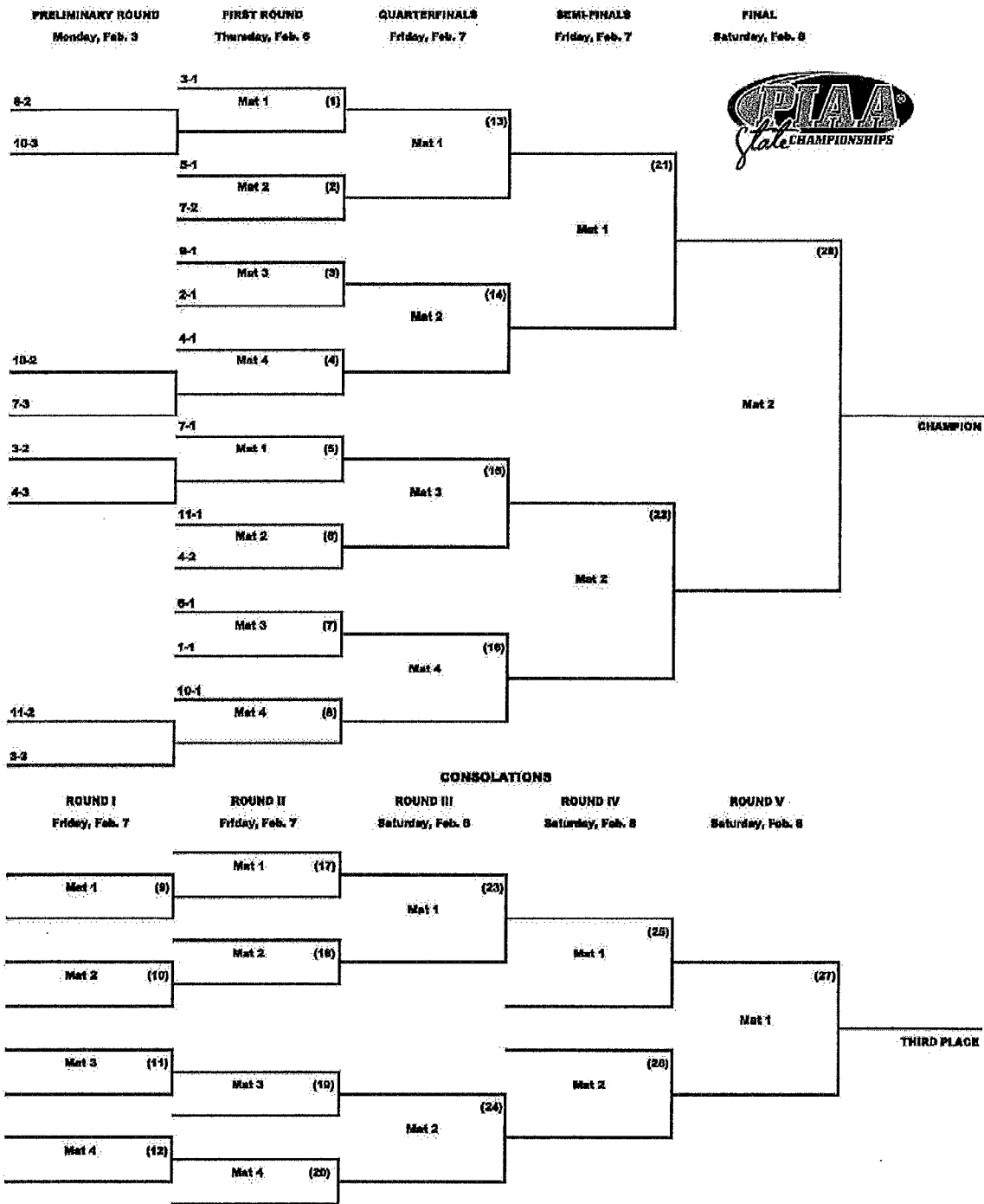
NOTE: CONSECUTIVE WEIGHT ALLOWANCES WILL ONLY BE PROVIDED AT THE TIME OF WEIGH-INS ON FRIDAY, FEBRUARY 7, 2020 AND SATURDAY, FEBRUARY 8, 2020. NO ADDITIONAL CONSECUTIVE WEIGHT ALLOWANCES WILL BE GRANTED ON THURSDAY, FEBRUARY 6, 2020 REGARDLESS OF WHETHER A PARTICIPATING SCHOOL HAS COMPETED ON WEDNESDAY, FEBRUARY 5, 2020, OR AS DETERMINED BY THE TOURNAMENT DIRECTOR.

The GIANT Center is situated adjacent to the community of Hershey, fifteen (15) miles east of Harrisburg, PA, along Hersheypark Drive. Directions to the GIANT Center from the respective East and West regions are as follows:

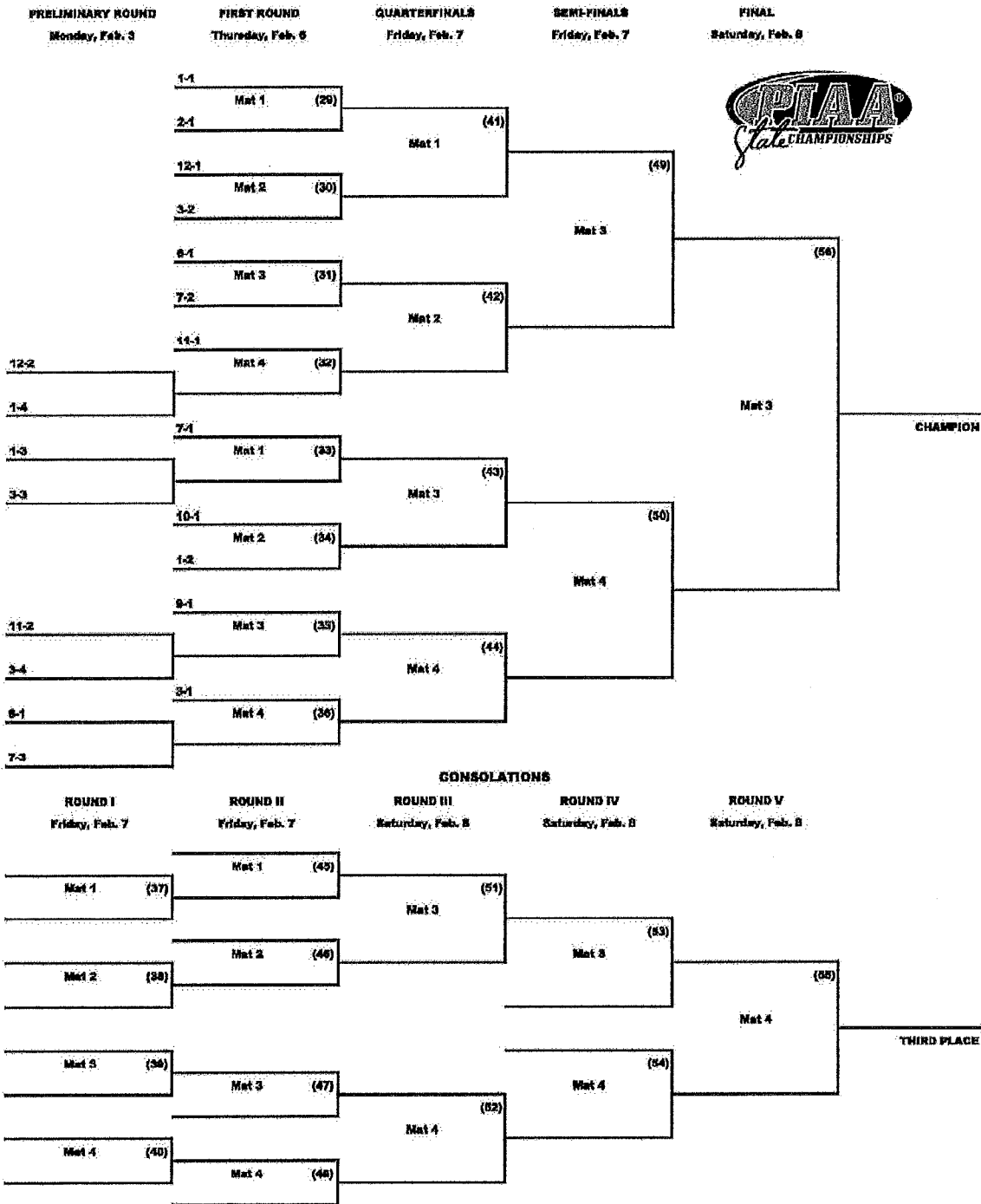
FROM THE EAST: Points north should use I-81 South to Grantville exit 80. Follow PA 743 South to Hersheypark Drive. Points south should use I-76 (PA Turnpike) West to Lebanon/Lancaster exit 266. Follow PA 72 North to US 322 then PA 743 North to Hersheypark Drive.

FROM THE WEST: Points north should use I-79 South to I-80 East to Woodland exit 123. Follow US 322 East to Hersheypark Drive. Points south should use I-76 (PA Turnpike) East to Harrisburg East exit 247. Follow US 322 East to Hersheypark Drive.

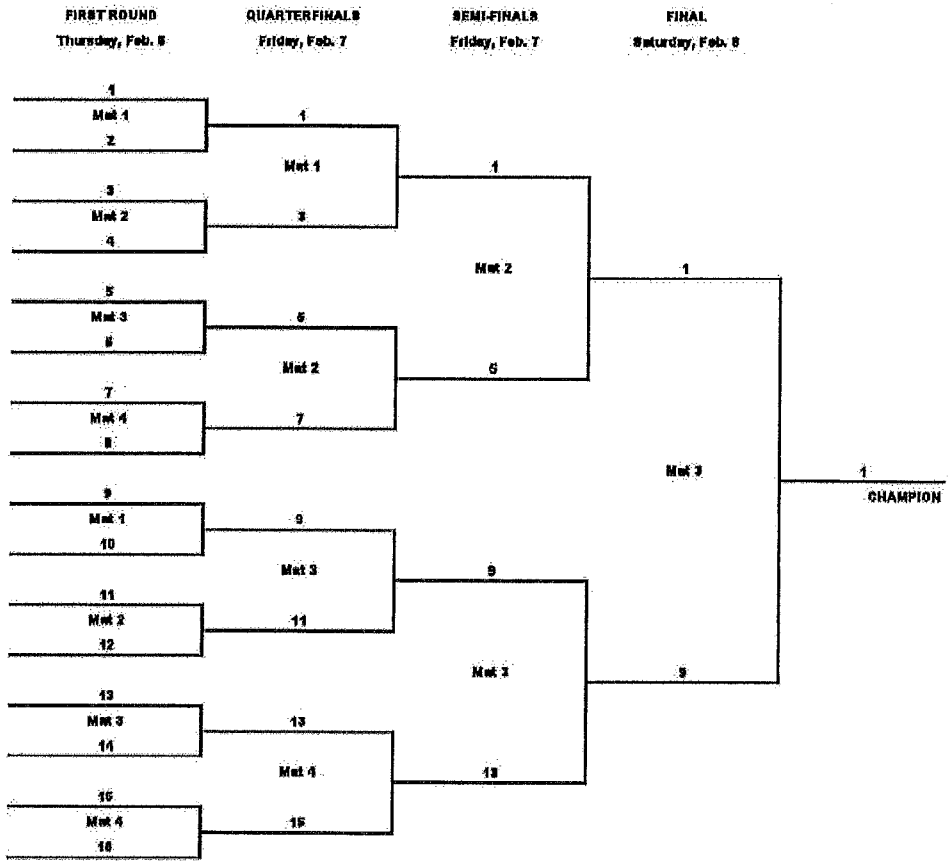
