#### VII. New Business

- Central Bucks South and Villa Joseph Maria Academy presented a self-report in reference
  to a girls' soccer game that did not play overtime when the score was tied in regulation.
  Upon motion by Steve Brandt/Mike Walker, the committee approved the self-report of
  Central Bucks South High School and Villa Joseph Maria Academy. The schools
  requested the opportunity to resolve the situation by playing the overtime period.
  Unanimous. (26 Votes)
- Devon Preparatory School has joined the Philadelphia Catholic League. Upon motion by Steve Brandt/John Reading, the committee approved DPS request for withdrawal from PIAA District 1. This will allow the Devon Prep to become a member of PIAA District 12.
   Unanimous. (26 Votes)
- Upon motion by Bill Bartle/Don Walsh, the committee accepted the withdrawal of membership Milford Middle School (Quakertown SD) as a result of the school closing.
   Unanimous. (26 Votes)
- All assignors were reminded that PIAA officials must be used even if a PIAA school is
  playing a non-PIAA school. All schools were reminded they are required by PIAA rule to
  have signed game contracts for each contest. League contests are considered contracted
  contests.

Bill Brown is an independent contractor appointed by PIAA D1. Mr. Brown will help provide technical services to the PIAA D1 Office in reference to Arbiter Support. Upon motion by Tom Brady/Maureen Gregory, the committee approved an annual stipend from services to District One to Mr. Brown at \$2500.00. Any member school or Assignor wishing to utilize Mr. Brown's services may do so upon their own agreement. District One is not responsible for payment of services provided to individual schools and assignors.

- Upon motion by John Reading/Tom Brady, the committee approved the Arbiter Use Policy. Unanimous. (26 Votes)
- Upon motion by Russ Wren/Jason Sherlock, the committee approved the motion to table the presented Assignor Use Process until October in order to seek additional research.
   Unanimous. (26 Votes)
- Official Playoff Observations topic will continue to be under discussion with the PIAA D1 Staff.
- The committee determined that an Official Pitch Counter D1 Baseball Playoffs would not be provided. The pitch count responsibilities for playoff games will follow the same rules/procedures as during the regular season.

## XI. Hearings

The committee moved into two sub-committees to conduct Hearings on behalf of schools requesting PIAA District 1 action.

- A. The PIAA District 1 Sub-Committee conducted a hearing on behalf of a student from Morrisville High School in reference to PIAA Constitution and By-Laws, Article VIII Section 6B. Upon motion by Jason Sherlock/Dave Baun, the committee approved the motion to grant two additional semesters of eligibility with the exception of football. 12 yes -1 no votes.
- B. The PIAA District 1 Sub-Committee conducted a hearing on behalf of a student from Upper Merion High School in reference to PIAA Constitution and By-Laws, Article I Section 3. Upon motion by John Reading/Sue Cornelius, the committee approved the Age waiver for the student in three sports, Cross Country, Swimming and Track and Field.

  Unanimous. (13 Votes)
- C. The PIAA District 1 Sub-Committee conducted a hearing on behalf of a student from Springfield (Delco) High School in reference to PIAA Constitution and By-Laws, Article VIII Section 6B. Upon motion by Chris Lunardi/Janet Columbro, the committee approved the motion to deny the request for an additional season of eligibility in the sport of basketball. Unanimous. (13 Votes)
- D. On August 23, 2017, a Sub-Committee of the PIAA District 1 committee conducted a hearing on behalf of a student from Bensalem High School in reference to PIAA Constitution and By-Laws, Article VIII Section B Item 6. The committee received a report on the action taken at this hearing. The subcommittee votes to approve two additional semesters of eligibility. **Unanimous (5 Votes)**
- E. On August 23, 2017, a Sub-Committee of the PIAA District 1 committee conducted a hearing on behalf of a student from VFMA in reference to the PIAA Constitution and By-Laws, Article VIII – Section C. The subcommittee votes to approve two additional semesters of eligibility. **Unanimous (5 Votes)**
