- Supplemental Disqualification rules. Reminder: Supplemental DQ = 2 game suspension and completion of NHFS programs.
- Transfer forms. Schools must fill out forms, not parents or students. Forms must be complete and accurate.
- Post-Season Waiver forms and rule updates will continue to be shared by the PIAA D1 Office.
- 30 Day Rule Waiver requests must be received 30 days prior to the start of the post-season.
