• Mr. Kelly recommended continuing conversation and implementations of issues related to PIAA D1 "playback" games in the brackets.

PIAA BOD Report – Dr. Barber

- Dr. Barber discussed the language and potential changes to PIAA Article VI, Transfers, Residence and Recruiting, Section 11.B.11. which address the identification of Feeder Schools and the permissions of school personnel to speak with students and parents/guardians before, during or after athletic contests. This adoption will be consider on a 3rd reading at the December PIAA BOD meeting.
- The discussion regarding the proper identification and definition of Feeder Schools will continue at the PIAA BOD level.

New Business

- Upon motion by RJ Bretz/Mike Semar, the committee approved the request for a Girls Wrestling Co-Op between Central Bucks West and Central Bucks East.
 23 Yes 0 No 1 Abstain (Henry Hunt).
- Mr. Bill Schmidt, Athletic Trainer at Abington High School spoke to the request for Athletic Trainers to be paid for coverage of PIAA D1 playoff games. The difficulty of the discussion falls into three categories which creates a dilemma in solving the situation.
 - a. Certified Athletic Trainers (ATCs) who are paid per diem.
 - b. ATCs being paid by outside contractors.
 - c. ATCs who are salaried employees of the school district and therefore fall upon the collective bargaining unit.

Presently, PIAA D1 upon submission pays *the school district*. This conversation has been referred to the District One Operations Committee and that committee. The Operations Committee will schedule a meeting and will report back to the D1 Committee.

 Del-Val League representative, Mr. LaDontay Bell made a presentation in reference to the Del Val League involving student athletes and opportunities. The Del Val League is a five-school league. Scheduling games is a continuous challenge. The District One office will continue to work with member schools to help establish working relationships between leagues. No action taken.

Old Business

- Girls Wrestling post-season dates and sites are still TBA. The Girls District Tournament is tentatively scheduled for February 17, 2023, site TBD. The Girls' D1.DXI.D12
 Regional Tournament is scheduled for the weekend of February 24th site still TBD.
 The Wrestling Sterring Committee.
- Volleyball Power Ranking System presently does not include matches of non-PIAA opponents. This topic will continue discussion. Leagues should meet and bring back information for the December Meeting. Recommendation is to include all non-PIAA opponents in the current ranking system.
- Discussion in refence to the minimum number of contests required for calculations of the Power Ranking system continued. No action was taken.
- Locations dates and times for the 5A and 6A basketball championships are still under discussion. There are conflicts at Temple University on March 2nd. The District One office will continue

Field Hockey Team. The Committee reviewed PIAA Article XVI – Season and Out of
Season Rules and Regulations. Upon motion by Joe Derickson/Geoff Per, the committee

- The committee held discussion in reference to Hearing Transcripts being sent to PIAA for appeal. Who is responsible for payment of the transcribing. Upon motion by Joe Erickson/Jason Sherlock, the committee approved the motion to record no meetings, whether in person or video. **Unanimous.** (22 Votes)
- There is now a conflict with Temple to host the PIAA D1 Basketball Championship sites and dates. Investigation of sites will continue.
