 Upon motion by Bill Bartle/Todd Vaccaro, the committee approved the recommendations of the PIAA District
 One Executive Secretary and Assistant Executive Secretary for the Fall Season. Unanimous. (26 Votes).

- Upon motion by Jason Sherlock/Steve Brandt, the committee accepted the Valley Forge Military Academy self-report and action plan Basketball fans. **Unanimous.** (25 Votes).
- Upon motion by Jason Sherlock/Dave Baun, the committee accepted the Neshaminy High School self-report and action plan Basketball fans. **Unanimous (25 Votes).**
- Upon motion by Bill Bartle/Todd Vaccaro, The committee accepted the Harry S. Truman High School followup self-report regarding the Girls Basketball Coach. **Unanimous.** (25 Votes).
- Upon motion by John Reading/Steve Brandt, the committee denied a recommendation made by the PIAA
 District One Swimming Steering Committee; the Swimming Steering Committee recommended to split the 3A
 Classification by enrollment for the 2019 District Championships.
 - 24-Yes, 0-No, 1 abstention Bartle (25 Votes).
- Upon motion by John Reading/Sue Cornelius, the District One Committee approved the recommendation of the District One Swimming Steering Committee to accept the Swimming/Diving qualifying standards for the 2018-2019 Championships. **Unanimous.** (25 Votes).
- Mr. Vaccaro expressed the concern / need for State-Playoff Neutral Sites in District One. Respectfully requests that all Committee members speak with member schools within their leagues to help assist District One and the PIAA with neural sites when their site is available.
- Mr. Walsh presented State playoff official assignment concerns. Rod Stone shared information about steps
 that will be taken to investigate a solution. Tom Brady shared concerns about the lack of available officials at
 the State level since many do not attend the PIAA Officials Conference once every five years to be play-off
 eligible. A Basketball Steering Committee Meeting is scheduled for April 25, 2018 at PW HS.
