- Committee members are asked to report changes of League alignments and changes to Sport Steering Committees to the D1 Office over the summer.
- Winter Sport revenues and expenses were reviewed and discussed. Copies of the Fall and Winter game report spread sheets are available for review upon request.
- Recommendation and approval to increase D1 Swimming Championship ticket prices to \$10/ session.

- Upon a motion by Denis Gray / 2nd Dave Baun, the District One Committee voted to increase the annual salary of the Executive Secretary by 3% effective July 1, 2019.
 Unanimous (25 Votes).
- Upon a motion by Denis Gray / 2nd Steve Brandt, the District One Committee voted to increase
 the annual salary of the Assistant Executive Secretary by 5% effective July 1, 2019.
 Unanimous (25 Votes).
- Upon a motion by Denis Gray / 2nd Dave Baun, the District One Committee voted to increase the phone and internet allowance of the District One Executive Secretary and Assistant Executive Secretary to \$100/month effective July 1, 2019. **Unanimous.** (25 Votes).
- Discussion of the District One Chairman and Vice-Chairman PIAA Meeting Honorarium was tabled until a later date. No action taken.
- D1 Committee Nominations Chairman and Vice Chairman
 - O Upon a motion by John Reading / 2nd Steve Brandt, the District One Committee approved the recommendation to re-elect Dr. Michael Barber as District One Chairman for the 2019-2020 school year. **Unanimous (25-0)**
 - Upon a motion by Matt Gionta / 2nd Reggie Parks, the District One Committee approved the recommendation to elect Dr. Pat Nugent as District One Vice-Chairman for the 2019-2020 school year. Unanimous (25-0)
 - Upon a motion by Ken McCormick / 2nd Russ Wren, the District One Committee approved the recommendation to approve Sue Cornelius as the District One representative to the PIAA Sportsmanship Committee. Ms. Cornelius will replace Russ Wren (retirement). Unanimous (25-0)
 - The District One Athletic Directors Association appointed Joe Derickson, Assistant AD at Garnet Valley HS, as the President of the D1 Athletic Director's Association. Mr. Derickosn will serve as the AD representative to the District One Committee.

• D1 Playoff Official Fees

- Upon a motion by Tom Brady / 2nd Lou Sudholz, the District One Committee approved the recommendation to increase the official pay base fee 2.5% for the 2019-2020 school year. Unanimous (25 votes)
 - Official playoff base fee will increase to \$38.99. District One will continue to use the approved pay rate formula which establishes playoff fees for each sport.
 - Assignors will also now use the use the 1st round playoff pay rate for D1 playback contests. The semi-final pay rate will not be applied for playbacks.
