- The DelCo Christian School has cancelled football for the 2018 season. BAL Schools on their schedule will be awarded forfeit wins if they are not able to schedule a new contest. No action taken.
- Penn Wood v. Council Rock North football contest will count as an 8-0 for Penn Wood unless the schools can agree to continue the contest from the point of interruption. NFHS Football Rule 3, Article 4 applies to this situation.
- The D1 Office received a report from Perkiomen Valley High School Football Self Report

   In Season Rule Violation. Upon motion by Pat Nugent/David Baun, the committee
   accepted the self-report with no further action taken. Unanimous (21 Votes)
- Bensalem High School received a Self Report Student Eligibility. The school played the student in two games and has forfeited the two games. Upon motion by Robert Findlay/Lou Sudholz, the committee approved the self-report. Unanimous. (21 Votes)
