- Upon motion by Sue Cornelius/Maureen Gregory, the committee approved the D1 Spring Playoff Qualifiers (2018-2019/2019-2020). Unanimous (22 Votes)

#### X. Hearings

The PIAA District 1 Committee conducted a hearing on behalf of a student at Norristown Area High School in reference to PIAA Constitution and By Laws, **Article III, Section 3 – Attendance**, **and Article X, Sections 3 and 5 - Curriculum**. Upon motion by Dave Baun/Sue Cornelius, the committee approved a motion to grant the request for waiver of Article III, Section 3 – Attendance. The committee was unable to approve the request of a waiver of Article X and voted to uphold the By-Laws, Article X, Section 3 and 5. As a result, the student will be ineligible to participate in interscholastic athletics for at least fifteen (15) school days of the next grading period.

The PIAA District 1 Committee conducted a hearing on behalf of a student at Springfield Township High School in reference to PIAA Constitution and By Laws, **Article I Section 3 - Age**. Upon motion by Pat Nugent/Steve Brandt, the committee denied the request for two additional semesters of eligibility, as there is no jurisdiction by the committee to suspend the application of the rule and waive the By-Law. **Unanimous. (17 Votes)** 

Upon motion by Sylvia Kalazs/Russ Wren, the meeting was adjourned at 1:00 pm. Unanimous (17 Votes)
