Executive Secretary Report – Mr. Stone / Mr. Kelly

- Sean Kelly presented the Winter Sports Championship updates.
 - Brackets and Championship information are posted on the website.
 - Host schools are reminded that cash sales are required at all contests.
 - Schools are encouraged to share the Hometown Ticket link for basketball games, so spectators are guaranteed admission to games.
 - Host schools are also reminded that proper game management communication should be sent to opponents before each contest
- Rod Stone presented an update on the status of Team Girl's Wrestling.
 - There will be a survey sent to schools after the post-season requesting an accurate account of the number of girls wrestlers on each team.
 - The Girls Wrestling Steering Committee will meet after the post-season to review and make recommendations for future individual and post-season events.

New Business

- The committee held discussion of the positive and negative ramifications of the Post-Season Waiver rule. (PIAA Article VI. Section 7). After a lengthy discussion, the District One Committee requested that Dr. Baber have the PIAA BOD review the efficacy of the Post-Season Waiver rule. Upon motion by Jonathan Bauer/ Joe Vogel, the committee approved the request to direct the Dr. Barber (District One Chairman) to bring the Committee's concerns to the PIAA Board for discussion. **Unanimous (19 Votes)**
- The District One Committee held discussion on the details and impact of the proposed legislation, [PA House Bill 41](#). Many member schools have been contacted by an independent source to sign a petition to support the Bill. The District One Committee has requested that Dr. Barber gather additional information regarding the proposed bill from the PIAA office, and if possible local legislators.

PIAA BOD Report

- Michael Barber presented a brief review of the current PIAA Board updates. The next PIAA Board of Directors meeting is Wednesday, February 18.

Old Business

- Doug Hackman, Principal of Dock-Mennonite, and Seth Frankenfield, athletic director, presented to the committee their concerns regarding the current eligibility rules under Article VII that the PIAA Rules of Foreign Exchange Students, allowing participation of one year only, adversely affects students at their school and a few other District One schools. The Dock Mennonite administration is requesting that an agenda item be placed on March PIAA BOD meeting agenda to allow a presentation to request that the Board review PIAA By-Laws, Article VII and consider multiple years of eligibility for Foreign Exchange and International students. The District One Office will submit that request.

Middle School Report – Joe Vogler

- Joe Derickson and Joe Vogel, and the D1 Athletic Director's Association plan to hold a second meeting for PIAA D1 Middle School athletic directors to be held in March. Additional details will be sent to member schools.

Officials Report – Ron Reidinger & Maureen Gregory

- Ms. Gregory requested the committee members to share the information to colleagues to be conscience of start times of District Basketball Games. Availability of officials is a priority and times for arrival should be taken into consideration.
