Executive Secretary Report – Mr. Stone / Mr. Kelly

- Sean Kelly previewed the Fall Sport Playoffs. Playoff dates and information are posted on the District One website. ADs are asked to review schedules and game results as we approach the post-season.
- Reminder to all ADs PIAA enrollment classification reports will open October 1st and close October 15, 2025. PIAA will be sending out emails to all member schools.
 - o Make sure school contact information is updated on the PIAA website
 - \circ Submit enrollment numbers 10/1 10/15
 - o Enrollment corrections must be submitted before 11/15
 - o Voluntary increase in enrollment classification must be sent to PIAA office.
- The committee held discussion in reference to Foreign Exchange / International Student v
 Foreign Student. The District One office will continue to work and gain clarity for the
 paperwork requirements.
- Discussion was held in reference to the PIAA / District One Ticket policy. District One will continue to utilize Hometown electronic ticketing. The District One office will provide specific guidance. No cash at games will continue.

New Business

- The committee conducted a hearing in reference to the Neshaminy Boys Volleyball Self-report and the use of an ineligible player during the 2025 District One playoffs. The Committee accepted AD Pennington's report and the school's self-imposed sanctions. The Committee placed the Neshaminy Boys Volleyball program on probation for a period of one year with additional conditions. Upon motion by Sudholz / Brandt, the District One Committee accepted the recommendations. Unanimous (24 votes)
- The District One Committee recommended Jim Cairnes, AD Wissahickon HS, to serve as the PIAA District One Flag Football Chairperson. Upon a motion by Bretz / Spera the District One Committee accepted the recommendation. **Unanimous (24 votes)**

- District One will establish a Flag Football Steering Committee based on the current District One policy. Currently the number of schools sponsoring Flag Football SOL 20 / AACA 2 / BAL 1 / Central 4 / Ches-Mont 6 / Del Val 6 / Pac 8). The number of schools and number of steering committee members will be reevaluated after the new classifications are established.
- The District One Committee voted to formally allow elected members of the District One Executive Office and Principals who serve on the District Committee to officiate and chair eligibility hearings when necessary. Upon a motion by Bauer / Sherlock the District One Committee accepted the recommendation. **Unanimous (24 votes).**

Old Business

• Seth Brunner led discussion in reference to the current District One Media Policy and the fees for school-based student broadcasting groups. Upon a motion by Brunner / Keenan, the Committee accepted the recommendation to only charge a media fee for Football playoff contests and other sport Championship contestants. Basketball games will no longer charge a fee if the "school group" is streaming or broadcasting playoff contests. Unanimous (24 votes).

- Dr. Barber reviewed the information presented at the September PIAA BOD meeting and the Annual Fall meeting. PIAA meeting minutes were sent to all member schools.
- Dr. Barber reviewed the information in reference to a court decision which allows faith-based school students to participate at their home school district. The PIAA consent order was sent to all ADs and building Principals outlining the current policies and procedures.
- Dr. Barber provided and update on the feeder school discussion. The PIAA BOD tabled the discussion at the last board meeting. Dr. Barber will chair a subcommittee to reintroduce updated feeder school language to the PIAA bylaws.
