Executive Secretary Report – Mr. Stone / Mr. Kelly

- Sean Kelly presented the Winter Sports Championship updates.
 - Thank you to CB South and their Administration for hosting the D1 Competitive Spirit Championships on January 4th. 21 schools qualified for the PIAA Championships on January 30-31, 2025.
 - Basketball Championship sites will be confirmed in the next few weeks. The basketball seed meeting is Sunday, 2/9. Schools are reminded they need to provide their non-D1 opponent's over records to the tabulator.
 - Wrestling post-season team and individual information will be sent to the coaches and ADs in the next few weeks.
 - Swimming / Diving sites and dates are posted to the D1 website. Qualifying information will be sent to coaches and ADs.
- Member schools are reminded of the deadline for Post-season waiver requests: <u>MUST</u> be submitted 30 days before the start of the post-season. The PIAA deadline to appeal a D1 decision is 15 days prior to the start of the playoffs.

New Business

- The District One Committee conducted a lengthily discussion in reference to an incident involving a Coatesville Girls Basketball – Player disqualification and player eligibility. No action was required, the committee will follow the rule interpretation provided by the PA Basketball State Interpreter and the PIAA office.
- The PIAA District One Committee will engage in strategic planning at future meetings. Topics that need to be considered, discussed, and clarified, include but not limited to:
 - Registration vs. application, middle school and 9TH grade timing/length of games, the balance of education based interscholastic athletics and club sports.
- Dr. Barber reviewed the role and responsibilities of the PIAA D1 Committee members to represent and communicate with their assigned constituency. Committee members are reminded of confidentiality.

PIAA BOD Report

• Dr. Barber discussed the proposed changes in the PIAA Bylaws concerning the identification of Feeder Schools for athletic recruiting purposes.

The D1 Committee has directed the PIAA D1 Chairman and Vice-Chairman to vote that enrollment of the top 4 schools from the previous cycle will become the accepted feeder schools for the next cycle. Upon a motion by Flynn Hensel/Lisa Ford, in reference to the subject of what is considered a "Feeder Schools" (Mission Based Schools, Charter Schools, and Private Schools) for recruitment purposes. Unanimous (24 Votes)
