- The District One office is searching for a location for the November 13<sup>th</sup> D1 Committee meeting. Please contact the office with any suggestions for locations.
- The committee held a lengthy discussion regarding MS sports Boys playing on Girls Teams. The PIAA BOD will add this topic to the December BOD meeting to discuss potential revisions to the language and interpretation of Article XVI Mix Gender Participation.
  - The D1 office will attend Middle School AD meetings to review PIAA rules and regulations.
- The committee held discussion regarding numerous concerns of schools adding / dropping games on their schedules late in the season. There currently are no specific rules or policies in place preventing schools from adjusting their schedules during the season. The District One Committee members are encouraged to go back to their leagues and bring back suggestions to remedy concerns that are brought forward.
- The committee held discussion regarding the Post-Season 30-day and 15-day rule for request of Post-season waiver appeals. The D1 Office will continue to educate and remind schools of the rule. There was no further discussion or recommendations to expand the submission of post-season waivers for post-season waivers.

- Upon motion by Reidinger / Creighton, the committee approved the process of assigning fall sports playoff officials in a fair and objective manner. **Unanimous (22 Votes)**
- Upon motion by Derickson / Hegen, the committee approved the 2023-2024 District One Audit Report from Boyer & Ritter. The 2023-2024 Audit Report is available upon request.
- Unanimous (22 Votes).
- Upon motion by Ford / Flynn-Hensel, the committee approved Greg Decina as the District 1 Boys Lacrosse Chair. **Unanimous (22 Votes)**
- The D1 Committee held discussion about HR 443 (sponsored by Representative Conklin). Additionally, Dr. Barber informed the committee of the various House Bills that have recently been introduced that concern the PIAA.

- Upon motion by Bretz / Hunt, the committee District One Committee accepted a self-report from Wissahickon MS concern a Report of Alleged Violations of PIAA Article XVI-Season and Out of Season Regulations, Section 4 Mix Gender participation.

  Vote 18 yes, 0 no -1 abstention (Bauer).
  - The D1 office will attend Middle School AD meetings to review PIAA rules and regulations with Middle School athletic directors. The District One executive officers spoke with the building principal and offered suggestions to help rectify the situation for the remainder of the season. The District One committee requested that the PIAA BOD improves the language in the by-laws to help with the interpretation of the rules. No additional action was taken

  - PIAA October summary was sent to member schools and has been posted on the PIAA website.
  - The PIAA BOD will continue discussion on improving the definition and application of Feeder Schools and recruiting in the PIAA By-Laws.
  - On a 2<sup>nd</sup> reading basis, the criteria of the PIAA Competition Formula were adjusted. 3<sup>rd</sup> reading will occur in December.
    - Change the number of Transfer in Team Sports
    - Change the number of points to move up in classification
    - Remove language on limitation of appeal related to health and safety.
  - The PIAA BOD approved the expansion of Girls Volleyball to 6 classifications for the next 2-year classification cycle.
