# **Executive Secretary Report** – Mr. Stone / Mr. Kelly

- Sportsmanship Banners for the 2019-2020 school year will be mailed from PIAA office to schools this month. This summer the D1 Office will be asking leagues to report Sportsmanship Award winners for the 2020-2021
- Spring Sports /Playoff Updates.
  - Seed meeting information has been sent to all member school ADs. Schools are reminded to update schedules, scores, and send records of all non-D1 opponents to the tabulators. Zoom link will be sent to all Steering Committee members. All coaches are welcomed to attend.
  - There will be a Spring playoff meeting for all ADs participating in the playoffs on Monday, 5/17. Zoom link will be sent to all ADs.
  - o Ticket sales / Game expenses will keep the same process as Fall and Winter.
  - o If schools need game tickets, please contact the main office.
  - O All team playoff contests will be held at the higher seed. Host schools are reminded there must be consistent representation for home and visiting schools. If the host school is unable to comply the game will be moved to another site.
  - Reviewed the COVID Memo which was sent from the D1 Office on 4/22 regarding Post-Season Covid Protocols.
  - Mask Rules continue to adjust. Schools are reminded to follow their own local health and safety plan.
  - o PIAA Mask Exemption forms are posted on the PIAA website.
  - D1 Track Championships will be held at Coatesville HS on 5/21 and 5/22.
    Spectators will be permitted. Coatesville will be sending their policy and guidance.
  - Sean Kelly presented a detailed Financial Report Review of previous Audit Reports. The report compared revenues and expenses from previous year and highlighted the losses incurred so far in 2020-21. The report outline the specific costs D1 pays throughout the year. # **PIAA BOD Report** – Dr. Barber

• PIAA D1 has concerns with the proposed PIAA start date/playoff date adjustments. The committee has recommended this discussion be held at the July summer PIAA Meeting.

• The PIAA Sports Medicine Committee is continuing discussion in reference to reduction of the minimum number of preseason practice dates. At this point there are no changes for fall 2021.

#### **New Business**

- Upon motion by the nomination Chairman, Dr. Jason Sherlock /Mike Lalli, the committee appointed Michael Barber as PIAA D1 Chairman and Stephen Brandt as PIAA D1 Vice Chair for the 2021-2022 year. **Unanimous (29 Votes)**
- Upon motion by Joe Derickson/Denis Gray, the committee approved the D1 Swimming Qualification Standards for 2022. There is no change from 2021. **Unanimous (29 Votes)**
- D1 Meeting Calendar was presented for review and approval. The Committee will approve the proposed dates and determine the times and locations of the meetings over the summer months.
- Rod Stone and Sean Kelly made recommendations to the committee to review the D1 Committee and Steering Committee / Steering Committee structure. Representatives are requested to discuss with their leagues. Topic will be reviewed and considered at the next D1 Committee meeting.
  - o Consideration: Should Conferences / Divisions be utilized or should the total number of schools in the league be the deciding factor of representatives?
  - Current policy: League representatives are determined by the number of schools in the respective leagues. A League / Division that has a membership of four (4) to six (6) member schools shall be entitled to one representative on the District Committee. A League / Division that has seven (7) or more member schools shall be entitled to two (2) Representatives.
  - Recommendation: Steering Committee representatives are determined by the number of teams in the respective league. Leagues shall be entitled to one (1) representative for every four (4) member schools that sponsor the specific sport. (Conferences/Divisions will no longer be used to determine Steering Committee Members)
- At the conclusion of the meeting the Mr. Gray (HR Chair) and the D1 Human Resource Committee met in Executive Session to discuss matters of personnel. The HR Committee will present a report at the next D1 Committee meeting.

#### **Officials Report -** Mr. Brady, Mrs. Gregory

• Maureen Gregory discussed the importance and need for an additional Girls Lacrosse Official's Chapter in District One. Mrs. Gregory and Dr. Barber will communicate with the PIAA office.

• Mrs. Gregory also expressed concerns about MS field conditions. She asks that all school AD examine their fields to ensure safe conditions for the players and officials.
